# Appendix A CHAIR'S REPORT

The first task I set for myself before I write any report for any organization, is to read my previous report. Primarily I do this, so it does not appear as if I have just made a few adjustments and date changes and then gone to my copy and paste function. But I will do that for my opening remark;

"I would like to start by welcoming everyone to the ORC 2019 AGM. Welcome!!" There, word for word the same, other than the date; because it is difficult to say it differently when it is sincere.

And for any of you who may have read my 2018 report; I do continue to believe [strongly], that ORC remains the number one organization in the province representing the interests of both

motorized and non-motorized outdoor and backcountry recreation. That ORC can do this is a testament to the dedication and commitment of all who sit on the Board of Directors. It is always easy to Chair a Board when we all agree on issues, but that is not always the case at ORC, given the diversity of interests we represent. Yet the job gets done, areas of common interest are identified, and responses to issues affecting outdoor recreation are agreed upon, with the expected compromise that may be required. Or if agreement can not be reached that lack of agreement is acknowledged with respect.

I will no longer be chairing ORC following this AGM, as my 6 years is done. It has been a pleasure to sit as a Board member from the Federation of Mountain Clubs, and to chair the Board. I have learned a great deal regarding the various interests that are represented at ORC. And I hope I have learned that it is essential to represent equally all those interests. And one of the first things I had to learn was that I was not coming to ORC to really represent the FMCBC. I was not there to demand action on FMCBC issues, to pound the table, so to speak. I was there to identify areas of common interest and encourage other organizations to do the same. To that end I don't think I ever gave a report at the ORC Board about the FMCBC, but nearly always gave a report at the FMCBC Board regarding ORC.

I am not going to list the many issues that ORC has been involved with over the past year, to do so would involve needless repetition on the many topics that are spoken to in the monthly Enews. Those with an interest should access that to keep abreast of issues and keep up to date with the latest developments.

The one topic I will comment on though, is the Provincial Trails Advisory Body [PTAB]. Last June those on PTAB representing government were required to step back regarding their involvement and commitment to that committee; due as I understand things, to changing priorities and pressures within government. There will always be changing priorities within government Ministries for a variety of legitimate reasons. Nonetheless, those of us on the ORC Board were disappointed and frustrated to receive this news and advised the government representatives at PTAB that we would not abandon this process. And we did not! As we moved into the Autumn months there were phone conversations specifically regarding the commitment of both government and ORC to PTAB. We were advised that government was in a position to reaffirm its commitment and in May PTAB held its first full day meeting of since last June. It was the first PTAB meeting I have attended, and I left reassured that those representing government are sincere in their commitment to this committee, and to reviewing and working towards implementation of the Provincial Trails Strategy.

I would also like to introduce Ms. Louise Pedersen. Louise was hired as the ORC Executive Director in February. Louise has recently been fully confirmed into this position following the completion of a 3-month period of probationary employment. I have every confidence that Louise will continue to be more than capable in this role, she has transitioned into the Executive Director position more fully than I would have expected during her first 3 months with ORC.

In closing I would like to also acknowledge and thank Dennis Webb, Past Chair of ORC, who worked tirelessly for ORC, and supported my transition into the Chair's position.

Thank-you also to Natalia Pisarek, who was a great help to me as the Chair of ORC following Jeremy McCall's passing almost a year ago, but who also was a good friend and valued employee during her entire stay with ORC. Natalia left the organization to pursue different career opportunities.

And a very big nod of appreciation to the entire Board who through their hard work made my life time as Chair a much more fulfilling experience than I had anticipated!

# Appendix B TREASURER'S REPORT

I am pleased to inform to the membership that the Council's fiscal year, ending March 31, 2019, has been good however not without its challenges. Our most significant challenge and change was as result of moving forward with filling the role of our Executive Director, formerly a volunteer position held by Jeremy McCall, with Louise Pedersen, former ED of NatureKids BC. This was financially only doable with the retirement of Natalia Pisarek, our Communications Coordinator, who respectfully carried us through the transition period following Jeremy's passing until we found our candidate to fill the vacant role. We are grateful to Natalia and pleased to welcome Louise.

# Highlights of this past year of operations;

- We have been successful in providing the Board with monthly financial reports as requested at our 2018 AGM
- We have developed and approved a working budget which will provide a framework and guidance for our operations
- We have recognized the liability regarding the Sea to Sea Trust fund as identified by Mr.
  McCall in last year's Financial Report and will be restoring this fund in this year's budget.
  We have already reduced this liability, in March, by \$2,896.74 Our current Liability is
  \$21,516.26 which is backed by our Accounts with Tangerine in excess of \$12,000 in
  conjunction with this years financial commitment within our operational budget.
- Redevelopment of our website
- Launched a Facebook initiative

We are reviewing our operational costs and will adjust were best suited to maintain fiscal responsibility with our operations. As with most not-for-profit businesses, we are faced with ongoing increasing costs.

- The office rent increased effective March 1, 2019.
- Receipt of a \$10,000 grant from Recreation Sites and Trails BC (RSTBC), was originally
  prior to year end, but it was not received until April 2019. It was set up as an account
  receivable for the year end and shown as expended. For 2019/2020 fiscal year we will
  be in discussions with RSTBC in seeking an increase of their financial support to enable
  ORC to meet the obligations of its working agreement with RSTBC.
- We are very appreciative of the funding provided from the Outdoor Recreation
   Foundation. During fiscal 2018/19 a total of \$45,000 was received from the Foundation,
   and we will be seeking the same for 2019/2020
- We will be aggressively seeking out other funding sources and opportunities to assist with ongoing and projected future expenses.

### **Our Cash Position**

Our current budgeting and financial process provides Council Directors with a monthly cash flow projection which will greatly assist with planning for our financial needs. We are currently managing well given our considerable increase in operational costs.

## **Looking Forward**

Subject to receiving requested support from the Outdoor Recreation Foundation as well as an increase from RSTBC, we will manage through this fiscal year. I look forward to further the development of a strategic plan, engaging with both the membership as well as with Government representatives as we identify and build upon "How are we to bring value to the you, the Membership, as well as to Government and how will we get there from both a labor and management as well as securing the necessary funds to do so".
