4. Reports

- a. Chair (WM): Louise's proposal to work from Denmark for a year, starting in July 2024. Motion to continue with Louise Pedersen as ED while remotely in Denmark for a year made by Dave Wharton and Seconded by Kim Reeves. Carried
- b. Executive Director (LP): Concluded annual appeal, 10K target, close to 8K raised, including \$2500 from our insurance company, 3-4 corporate donors, Ambler donated 100 hats. Meeting last week with Minister Cullen and PS Donnelly which resulted in commitments to quarterly meetings between ORCBC and WLRS and Minister Cullen spoke positively about funding for ORC. LP also had recent meeting with with MLA Roly Russell, PS for Rural Development. He's interested in outdoor recreation and benefits to rural communities. Next webinar is on outdoor recreation and reconciliation 300 registrants so far. For project with UBC, LP committed to having 5 people being interviewed about volunteering, looking for anyone interested. ORC needs to establish ourselves as being able to work with diverse groups, put forward a proposal to establish doing work for funding. LP will look into more funding options. (see action items)
